The coordination of the Health Sciences' Graduate Program (NPGME) of the Federal University of Sergipe makes public this Notice and rules for selection to fill one (01) vacancy of the National Postdoctoral Program (PNPD / CAPES) in Brazil.

1. GENERAL INFORMATION

For purposes of this Notice, the Health Sciences' Graduate Program of the Federal University of Sergipe summon doctors in order to promote the achievement of high-level studies in the research groups of NPGME, promoting the inclusion of new Brazilian and foreign researchers in post-doctoral on research projects developed in the NPGME.

2. NUMBER OF VACANCIES

It is offered one postdoctoral vacancy.

2.1. POST-DOCTORAL SCHOLARSHIP

The program will offer a monthly PNP / CAPES scholarship in a value of R\$ 4,100.00. The scholarship will be granted for up to 60 months for scholars who doesn't maintain any kind of employment or for up to 12 months if the grantee keep away from activities and do not hold the bond with the same Higher Education Institute from which the PNP scholarship is provided, according to CAPES' Ordinance No. 086 of July 3th, 2013. 2.2. THE POST-DOCTORAL DURATION

The Postdoctoral Fellow will have a minimum of twelve (12) months and a maximum of sixty (60) months with annual renewal. It should be started during the year 2013.

3. GENERAL REQUIREMENTS FOR CANDIDATE SELECTION

3.1 General Requirements:

- a) If foreigner, copy of passport with valid visa.
- b) If Brazilian, be up to date with compulsory voting;
- c) Do not be retired;
- d) Curriculum Lattes updated and proven.
- e) Have doctoral degree (Foreign institution diploma will be evaluated by NPGME)
- f) Have a research project linked to a NPGME research group to be developed in the period of the course, in triplicate, with a maximum of 20 pages, line spacing 1.5 cm. The project must include: INTRODUCTION, OBJECTIVES, LITERATURE REVIEW, METHODS, BUDGET, SCHEDULE AND REFERENCES.
- g) Have expertise in research areas that bring innovation to the NPGME research groups
- h) Be able to initiate activities related to the project as soon as your application is approved, and in accordance with a schedule to be established between the candidate and his/her supervisor.
